Enclosed find our three page final campaign finance report re the above matter. You will note that we filed our initial report with your office and the Brattleboro Town Clerk's Office o/a June 19, 2010.

I contacted your office a couple of time in the past two days and was referred to a David Crossman, but I never got beyond his voicemail. As I indicated in my messages to him, the purpose of my call was to obtain a blank copy of the 'Details of Expenditures' form so I could finalize our final four expenses. However, I have not received a return call from him as of the time of drafting this letter so I proceeded to complete that section of this report by continuing from where I left off on the initial expenditure form. I was not able to print that form off your website because it was on an excel format rather than a 'pdf' format used on the first two pages of this report. Apparently, since I do not have Microsoft Office, I am unable to so print 'excel' documents (I'm told). At any rate, you now have a complete and accurate report of our financial affairs during the course of our campaign so I trust you will find everything in order on this matter.

As you can see, we had no further contributions during the final ten days of this campaign and have no outstanding debt owing or forgiven. We had a small surplus of funds in the amount of \$68.18 after paying all bills and gave that surplus to ReNew Building Material & Salvage Inc., a non-profit charitable agency of Brattleboro, to close out our checking account at Chittenden Bank.

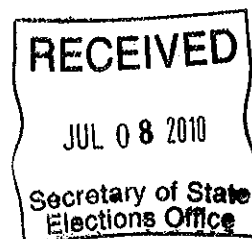

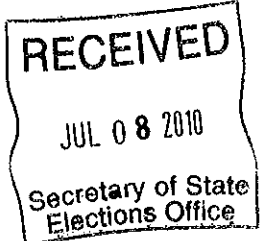
